Downtown Lee's Summit Farmers Market Food Truck Requirements

Please read through all the requirements for Food Trucks at the Downtown Lee's Summit Farmers Market. Applications will not be accepted for food trucks who do not meet all our requirements.

- Food Truck must arrive by 7:30 am on Saturday mornings and must stay until noon. Market opens at 8 am.
- Generator must not be louder than 55 decibels.
- Food Truck must have Jackson County Temporary Food Handler's Permit or Mobile Vending Permit.
- Must have City of Lee's Summit Business License.
- Must be inspected by the LS Fire Department or have current inspection sticker from Heart of America Fire Chiefs Council.
- Trash receptacles on site are for customers only. Food Truck must take trash with them and dispose off-site.
